Please stick to this time pattern when preparing your talk. This is the only way we can guarantee a smooth and satisfying industry program and allow all conference participants to attend as many slots as possible without missing important information.

Please take care to address the following aspects in your talk:

- Initial Situation What kind of challenge did you face in the beginning oft the project? What problems needed to be solved?
- □ Approach and IT-Solution Which approach and methodology has been chosen to tackle the problem(s)? How is your solution composed with respect to technological aspects / human aspects / organisational aspects? How do the semantic components support the process from data to knowledge?
- Success Criteria for / Benefit of the Semantic Solution Which factors (conscious and unconscious) have been crucial to the success of your project? Which obstacles did you face? How can you measure the benefit of your solution? How does the organisation profit from your solution?
- Prospects and Recommendations What are the next steps planned in your project? Can you give recommendations with respect to the development / deployment of semantic solutions within organisational / corporate settings?
- Demo Prepare a short demonstration of your tool / service.

After the submission deadline has ended (June 03, 2013) we will provide you with detailed information on organisational issues according the selection of submissions and conference participation.
